EPA Seeks Small Businesses to Participate on Carbon Tetrachloride and Trichloroethylene Panels

Deadline for self-nominations is December 14, 2020

The U.S. EPA is inviting small businesses, governments and not-for-profits to participate as a Small Entity Representative (SER) to provide advice and recommendations to Small Business Advocacy Review Panels for carbon tetrachloride and trichloroethylene (TCE). The panels will focus on the agency's development of proposed rules to address unreasonable risks identified in EPA's recently completed final risk evaluations for carbon tetrachloride and TCE.

Carbon tetrachloride is used in commercial settings as a raw material for producing other chemicals like refrigerants, chlorinated compounds, and agricultural products. Carbon tetrachloride is not currently used as a direct reactant or additive in the formulation of consumer products.

Common commercial uses of TCE are as a solvent in industrial cleaning/degreasing, an ingredient in adhesives and sealants, in paints and coatings, and in automotive care products like brake cleaners. Consumer uses include cleaning and furniture care products, arts and crafts spray coatings, and automotive care products like brake cleaners, and other consumer products.

New stoves are cleaner burning, which helps our local air quality. New stoves are also more efficient and use less wood so you can save money each winter on heating your house.
