In 2013, the Nevada Legislature passed the Cottage Food bill. This bill allows certain foods to be prepared and sold from a person's home. The Southern Nevada Health District is the health authority for Clark County.

Environmental Updates

Small Quantity Generator Re-Notification Due September 1, 2021

Is your facility a Small Quantity Generator (SQG) of hazardous waste? If so, you must re-notify the state of your status as a SQG by September 1st of this year. To re-notify, businesses must submit the <u>EPA Site Identification</u> form known as Form 8700-12. This form can be submitted online into EPA's information system at the <u>RCRA Info</u> website. If you do not have an account in the system, the Nevada Division of Environmental Protection has <u>step by step instructions</u> to help you set it up. Not only can you re-notify through this website, but you can also submit manifests through your RCRA Info account.

If you prefer not to use the online system you may submit a paper notification, with an ink signature, to the state by sending your completed Form 8700-12 to:

Regardless of how you submit the form, it is helpful to include the reason for the submittal on the form. Box number 18 on Form 8700-12 provides space for your comments. Providing a comment such as "This form is submitted to fulfill our SQG Re-notification requirement", will assist the state in processing the information.

While the requirement is straightforward, it does take some time to complete the form. Summer will go by fast! Fill out your form early and enjoy the summer without this deadline looming at the end of the season. Need help in filling out your form? Contact us for assistance.

US EPA Announces Plan to Update Toxics Release Inventory to Advance Environmental Justice

On April 29, 2021, the US Environmental Protection Agency (EPA) announced in a <u>press release</u> that it would be reviewing and updating the <u>Toxics Release Inventory</u> program to advance Environmental Justice, improve transparency, and increase access to environmental information. The comprehensive plan for updating the TRI program includes:

 Expanding TRI reporting to include certain contact sterilization facilities that use ethylene oxide (EtO) and are not currently required to report this information,

- Adding TRI reporting requirements for other <u>industry sectors</u> including natural gas
 processing facilities and <u>TRI-listed chemicals</u> including additional per and polyfluoralkyl
 substances (PFAS) and ethylene oxide, and
- Adding additional tools for TRI <u>communities</u> including launching a <u>Spanish version</u> of the TRI website.

American Lung Association Releases Air Report for 2021

The <u>American Lung Association</u> recently released its <u>State of the Air Report for 2021</u>. This report analyzes data from official air quality monitors across the United States that is collected by the federal, state, local and tribal governments to gather information such as ozone and particulate matter pollution.

According to the American Lung Association, one in every four Americans is living in a location with unhealthy levels of ozone or particle pollution and people of color are over three times more likely to be breathing the most polluted air. Las Vegas-Henderson is ranked 12th on the American Lung Association's list of 25 cities most polluted by ozone.

The staff at <u>BEP</u> assists business owners and managers with understanding and complying with environmental regulatory requirements, air quality permitting, and exploring cost-effective ways to reduce wastes and emissions. Funding Opportunities

Restaurant Relief Fund Now Open

Restaurants and other food and beverage businesses are eligible

Established as part of the American Rescue Plan Act, the <u>Restaurant Revitalization Fund</u> (RRF) is now available to help restaurants keep their doors open. RRF will provide restaurants with funding equal to their pandemic-related revenue loss up to \$10 million per business and no more than \$5 million per physical location. Recipients are not required to repay the funding as long as funds are used for eligible uses no later than March 11, 2023. The following entities are eligible:

- Restaurants
- Food stands, food trucks, food carts
- Caterers
- Bars, saloons, lounges, taverns
- Snack and nonalcoholic beverage bars
- Bakeries (onsite sales to the public comprise at least 33% of gross receipts)
- Brewpubs, tasting rooms, taprooms (onsite sales to the public comprise at least 33% of gross receipts)
- Breweries and/or microbreweries (onsite sales to the public comprise at least 33% of gross receipts)
- Wineries and distilleries (onsite sales to the public comprise at least 33% of gross receipts)

- Inns (onsite sales of food and beverage to the public comprise at least 33% of gross receipts)
- Licensed facilities or premises of a beverage alcohol producer where the public may taste, sample, or purchase products
