NAC 445B.281 - Violations: Classification; administrative fines. (NRS 445B.210, 445B.300, 445B.470, 445B.640)
 2. For Class II sources, violations of NAC 445B.22037, 445B.22067, 445B.2207, 445B.22087, subsections 3 and 4 of NAC 445B.232, subsection 8 of NAC 445B.252, subsection 2 of NAC 445B.265, paragraph (e) of subsection 1 of NAC 445B.275 and NAC 445B.331 are classified as minor or lesser violations, unless there are four or more violations of any one of those sections by a person, occurring within a period of 60 consecutive months.
 4. All minor violations become major violations upon the occurrence of the fourth violation of the same section within a period of 60 consecutive months.
NAC 445B.283 - Violations: Manner of paying fines. (NRS 445B.210, 445B.640)
 1. The amount of the specified fine, in accordance with the schedule of fines for minor violations, must be submitted within 10 days after service of the notice upon the violator.

An appeal of this Notice of Alleged Violation may be requested pursuant to Nevada Revised Statute (NRS) 445B.360 and State Environmental Commission (SEC) administrative rules. Appeals must be received within ten (10) days of receipt of this Notice of Alleged Violation pursuant to NRS 445B.340. Appeals are processed through Sheryl Fontaine, the Executive Secretary for the SEC, at 901 South Stewart Street, Suite 4001, Carson City, Nevada, 89701-5249. NRS 445B.640 - Levy and disposition of administrative fines; additional remedies available; penalty for failure to pay administrative fine.

4. Any person who fails to pay a fine levied pursuant to subsection 1 or 2 within 30 days after the fine is imposed is guilty of a misdemeanor. The provisions of this subsection do not apply to persons found by the court to be indigent.
