2024 Compliance Calendars Now Available Make Recordkeeping Easy in 2024!

Download our 2024 Hazardous Waste Compliance Calendar! The calendar includes space for your facility to document weekly inspections, staff training, waste determinations, and more. The calendar also contains compliance tips and QR codes to helpful resources to keep your facility in compliance with hazardous waste regulations. Download the calendar [here](#).

The 2024 Dry Cleaner Calendar is also available for download [here](#). If you use perchloroethylene, or perc, as your dry cleaning solvent then this calendar can help you maintain compliance with state and local air quality regulations throughout the year. If you use perc, do not forget to keep an eye on US EPA's proposed 10 year total phase-out for the use of perc in dry cleaning, with compliance dates depending on the type of machine used.

Biennial Reporting Workshops: January 9th (Reno) and January 11th (Las Vegas)

If you generated at a large quantity generator (LQG) status (greater than 2,200 lbs of hazardous waste in a calendar month) for any month during 2023, you must complete a biennial report through RCRAInfo. BEP is offering two FREE workshops in January 2024 to help generators complete and submit their report.

The workshops will be conducted in a computer lab where BEP staff will assist users with the RCRAInfo software and allow users to begin the biennial reporting process. Please bring your RCRAInfo login information and reporting paperwork if you would like to work on your report during the workshop.

EPA Requests Comment on Draft Memorandum Implementing Climate Resilience in Hazardous Waste Permitting

On December 12, [EPA is requesting public comment](#) on a draft memorandum that would provide guidance to EPA Regions, states, and territories on when and how to consider potential adverse climate change impacts in the hazardous waste permitting process under the Resource Conservation and Recovery Act.

This draft guidance includes expectations for conducting climate change vulnerability screenings and assessments for treatment, storage, and disposal facilities to determine whether there are climate vulnerabilities that hazardous waste permits should address. Read the draft memorandum [here](#).

Hazardous Waste Basics Get Your Facility Back to Basics for the New Year!

Minimize your waste and save money for 2024!

Don't forget, if you generate hazardous wastes, then you are certifying on your hazardous waste manifests at item 15 that you "have a program in place to reduce the volume and toxicity of waste generated to the degree... to be economically practicable" if you are a large quantity generator. Small quantity generators are also certifying that they are making "a good faith effort to minimize... waste generation."

Some helpful tips and strategies include:

- Purchase less hazardous materials where possible; seek products on the US EPA Safer Choice certified products list whenever possible
- Design your processes without the use of hazardous materials
- When you cannot design hazardous materials out of your processes, use hazardous materials as efficiently as possible
- Create a schedule to routinely manage your inventory and minimize expired products; use a first-in, first-out inventory management system
- Adopt in-house recycling systems

Sustainability Corner

School Bus Rebate Program NOW OPEN!

The Bipartisan Infrastructure Law of 2021 authorizes EPA to offer rebates to replace existing school buses with clean and zero-emission (ZE) models. The US Environmental Protection Agency (EPA) is accepting new applications for 2023.

The [2023 Clean School Bus \(CSB\) Rebates](#) process includes [SAM.gov](#) account registration, rebate application submission, review and selection by EPA. Selectees will then submit purchase orders to request payment and then receive payment, which is followed by new bus delivery, existing bus replacement, and project close out.

Clean School Bus Rebate Application Form

This form is used by applicants to apply to the rebate program. Once applications are submitted to EPA, EPA utilizes a selection process that is outlined in Sections 2 and 6 of the [2023 Clean School Bus \(CSB\) Rebate Program Guide \(pdf\)](#) (September 2023, EPA-420-B-23-032) and reviews the applications. If an application is awarded for funding, a Payment Request Form needs to be completed (see section below).


