Regulatory Updates

e-Manifest User Fees for FY 2026/FY 2027

EPA has posted the [FY 2026/FY 2027 e-Manifest user fees](#):

Submission Type	Fee
Image Only	\$25.00
Data + Image	\$7.00
Electronic/Hybrid	\$5.00

Note that the fees are part of a phased approach to transition away from paper manifests and implement fully electronic manifesting infrastructure. If your facility does not already have a user account in [RCRAInfo](#) to be able to use e-Manifest, register today and contact BEP for assistance with registration.

Updated Webpage for Hazardous Waste Cleanups

Looking for technical assistance on hazardous waste cleanups? EPA updated its [Hazardous Waste Cleanup Training webpage](#) to offer the tools and resources you may need for a cleanup. Additionally, EPA recently created a [searchable database](#) of over 200 hazardous waste cleanup resources to help answer your hazardous waste cleanup questions.

Reminder: 2025 RCRA Deadlines

- September 1, 2025: Small quantity generators are required to re-notify NDEP of their generator status. This re-notification occurs every four years and is intended to help states maintain accurate data of hazardous waste activities. Re-notification is completed by submitting [EPA Form 8700-12](#) or through your account in [RCRAInfo](#).
- December 1, 2025: Exception, Discrepancy, and Unmanifested Waste Reports must be submitted through [e-Manifest](#) as a result of [EPA's Third Rule](#). Export manifests are also required to be submitted to e-Manifest and exporters are responsible for paying [user fees](#). Lastly, hazardous waste shipments must use the new 4-page Uniform Hazardous Waste Manifest.
